Location



The Lanchesters are conveniently located on Fulham Palace Road opposite Charing Cross Hospital and approximately 10 minutes' walk from Hammersmith Broadway.

Hammersmith Broadway has excellent communication links by rail and road. The A4 can be accessed from The Broadway and gives easy access to Central London and West to the M4, M25 and the motorway network. By rail Hammersmith has the benefit of the Piccadilly, District and Hammersmith & City Underground Lines.
